**ARTICLE I: NAME**

The name of this corporation shall be The Boise Church of Christ, of Boise, Idaho, Inc.

**ARTICLE II: PURPOSE**

We seek to conform to the will of God as personified in the life of Jesus Christ, whom we come to know through the Bible.

**ARTICLE III: MEMBERSHIP**

Those who believe in Jesus Christ as Lord and Savior, and who express the same in baptism, receiving the gift of the Holy Spirit, will be accepted as members of the Boise Church of Christ. We believe the Bible teaches that regular participation in the duties and services of the church is necessary for the edification of the congregation (Hebrews 10:22-25). As a result, we believe that members should seek to identify with the congregation and regularly participate in its' duties and services.

All members are expected to live lives faithful to their identification with Jesus, committing themselves to the welfare of the congregation and submitting themselves in congregational matters to the oversight of the **ELDERS**.

If discipline of a member should ever prove necessary, it will be pursued in accordance with the spirit of love and correction stipulated in 1 Corinthians 5:1-11, and it will be carried out in compliance with the teaching of Jesus found in Matthew 18.

**ARTICLE IV: LEADERSHIP**

The life and service of the congregation will be governed by the Bible, with the **ELDERS** serving to lead the congregation in establishing the ways and means of our corporate life and worship, and the **DEACONS** serving to facilitate proper maintenance of all physical, material and financial affairs necessary for the fulfillment of the congregation's spiritual duties.
