**ARTICLES OF INCORPORATION
OF
PRESTIGE AUTO BODY, INCORPORATED**

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act (Idaho Code §30-1-1 et seq) adopts the following Articles of Incorporation for such corporation:

I. NAME

The name of the corporation is PRESTIGE AUTO BODY, INCORPORATED.

II. DURATION

The period of its duration is perpetual.

III. PURPOSES

The purposes for which this corporation is organized is to repair damages to the exterior of motor vehicles; and to transact any and all other lawful business allowed by a corporation of the State of Idaho.
