


CERTIFICATE OF INCORPORATION **OF**

The undersigned, natural persons acting as incorporators in order to form a corporation under the provisions of the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

Article 1. Name. The name of the corporation is ROSWELL LAND AND LIVESTOCK CO., INC.

Article 2. <u>Purpose and Object</u>. The purpose and object for which the corporation is formed is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Corporation Act.

Article 3. <u>Duration</u>. The corporation is to have perpetual existence.

Article 4. Registered Office and Agent. The location and street address of the initial registered office of the corporation is 889 Chardie Court, Boise, ID 83702. The initial registered agent of the corporation shall be Bob Lane who conducts business at the above address.

Article 5. Aggregate Shares. The aggregate number of shares which the corporation shall have the authority to issue is 500 shares of \$100.00 par value.

Article 6. <u>Initial Incorporators</u>. The number of the initial incorporators is two (2) and their names and post office addresses are as follows:

Article 7. <u>Initial Directors</u>. The number of the initial directors shall be two (2) and their names and post office addresses are as follows:

Article 8. <u>Preemptive Rights.</u> Stockholders of the corporation shall have preemptive and preferential rights of subscription of any shares of stock of the corporation whether now or thereafter authorized or to any obligations convertible to stock of the corporation and any such stock or obligation issued by the corporation shall first be offered to the stockholders of the corporation.

Article 9. Amendment of Articles and By-Laws. The initial By-Laws of the corporation shall be adopted by the majority of the Board of Directors. A majority of the Board of Directors or shareholders shall have the power to alter, amend or repeal the By-Laws or adopt new By-Laws. The corporation reserves the right to amend, alter or repeal these Articles of Incorporation in the manner prescribed by law, by a majority vote of the stockholders.
