

Certificate of Incorporation of the Idaho
Telegraph Company:

Territory of Idaho;
County of Ada;

We the undersigned being
desirous of forming a corporation for the
purpose of constructing Telegraph Lines
do hereby certify and declare as follows,
to wit:

- 1^o That we do hereby form such corporation
under and in pursuance of the Laws
of the Territory of Idaho;
- 2^o That such corporation shall be known by the
name of the Idaho Telegraph Company
- 3^o That the object of the corporation shall be
to construct and maintain Telegraph
Lines from Elko, Nevada, to the towns of
Cope, Nevada and Silver City, Boise City,
Idaho City, Council City and Haileyville
Idaho Territory, and such other towns in
said Territory, and other States and Territories
as may be hereafter determined, if
by said company, and also to establish
Telegraph Offices on said lines and de-
al a general Telegraphing business and receive
and collect pay therefore.
- 4^o The amount of Capital Stock of said corporation
shall be One hundred and fifty thousand Dollars \$150,000.

- 3^d Said Corporation shall exist for the term
of Fifty Years (50).
6^t The Capital Stock of this corporation shall
be divided into Fifteen Hundred (1500) shares
of One Hundred (100) Dollars each.
7^d That the number of Trustees who shall
manage the concerns of said corporation
shall be seven, and the names of the Trustees
who shall manage its concerns for
the first three months are Geo Greathouse, C.
Jacobs, L.W. Moore, J.S. Reynolds, E. Pinkham,
John Lump - and H.R. Mann,
