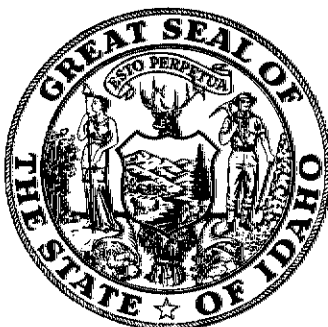

1. Name.
