THE UNDERSIGNED, A NATURAL PERSON, FOR THE PURPOSE OF ORGANIZING A CORPORATION FOR CONDUCTING BUSINESS AND PROMOTING THE PURPOSES HEREINAFTER STATED, UNDER THE PROVISIONS AND SUBJECT TO THE REQUIREMENTS OF THE LAWS OF THE STATE OF IDAHO, HEREBY CERTIFIES THAT:

1. AEI CORPORATION IS THE NAME OF THE CORPORATION, HEREINAFTER REFERRED TO AS THE "CORPORATION".

2. THE ADDRESS OF THE CORPORATION IS 1298 EAST FRONTAGE ROAD, POCA TELLO, IDAHO 83202.

3. THE CORPORATION SHALL CONDUCT ANY LAWFUL BUSINESS AND ENGAGE IN ANY LAWFUL ACTIVITY FOR WHICH CORPORATIONS MAY BE ORGANIZED UNDER THE LAWS OF THE STATE OF IDAHO.


BY THE NUMBER OF DIRECTORS TO BE ELECTED.
