ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

MINGO, ÍNC.

WE, the undersigned, BISH JENKINS, as President, and GALE W. CLEMENT, as Secretary, of MINGO, INC., do hereby certify:

That on February 1, 1971, the following amendments to the Articles of Incorporation of Mingo, Inc. were adopted by the unanimous written consent of all Stockholders of said corporation entitled to vote:

1.

RESOLVED: That Article V of the Articles of Incorporation shall be amended by deleting said article in its entirety and substituting in lieu thereof the following:

ARTICLE V.

That the shares of stock of said corporation are not to be classified and shall all be common stock, and that the authorized shares of said corporation shall be ONE HUNDRED THOUSAND (100,000), of the par value of ONE DOLLAR (\$1.00). Each share of common stock shall be entitled to one (1) vote and shall represent all of the voting shares of the corporation. That said shares of stock shall be fully paid up before being issued and after issuance shall be non-assessable.

2.

RESOLVED: That Article VI of the Articles of Incorporation shall be amended by deleting said article in its entirety and substituting in lieu thereof the following:

ARTICLE VI.

That the number of Directors of said corporation shall be fixed by the By-Laws of the corporation; provided, however, said corporation shall not have less than three (3) nor more than seven (7) Directors.

Except as provided above, the original Articles of Incorporation of Mingo, Inc. shall remain in full force and effect.
