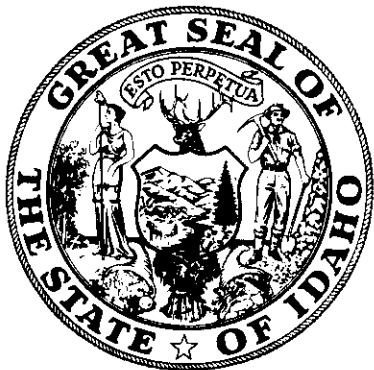

ARTICLES OF INCORPORATION
FOR
THE SOUND AND LIGHT SHOW, INC.

The undersigned being all natural persons of the age of twenty-one (21) years or more, and acting as incorporators of a corporation under the Idaho Corporations Act, adopt the following Articles of Incorporation.

I

The name of this corporation shall be THE SOUND AND LIGHT SHOW, INC.

II

The term of this corporation shall be perpetual.

III

The purpose of this corporation is to engage in the business of distributing and retailing video equipment and video software, and to engage in any other business not forbidden by law.

IV

The name of its registered agent shall be John J. Franzen. The address of its initial registered office is Post Office Box 2731, Pocatello, Idaho 83201 [393 Yellowstone, Suite C].

V

It shall have authority to issue five thousand (5,000) shares of common stock at a par value of One Dollar (\$1.00) per share, for an aggregate par value of Five Thousand Dollars (\$5,000).


All stock shall be common stock and each share issued shall be entitled to one vote at meetings of the stockholders of the corporation.




