COMES NOW, CHRISTOPHER COSTA and DEBRA COSTA, the original incorporators under the Articles of Incorporation of COSTA, INC., and do hereby submit and offer for filing, the Corrected, Amended and Restated Articles of Incorporation of COSTA, INC., an Idaho Corporation, as the same were filed with the Secretary of State on the 25th day of March, 2003, and pursuant to Idaho Code 30-1-103, state as follows:

1. That the name of the Corporation is COSTA, INC.;
2. That the following Amendments, by way of Correction, Amendment and Restatement of the Articles of Incorporation was approved by the Board of Directors and the Shareholder thereof at a meeting noticed and called for that purpose on the 27<sup>th</sup> day of June, 2006, in accordance with Idaho Code 30-1-1003.

3. That the Corrected, Amended and Restated Articles of Incorporation are as follows:

**ARTICLE I.**


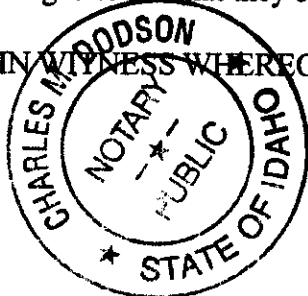
