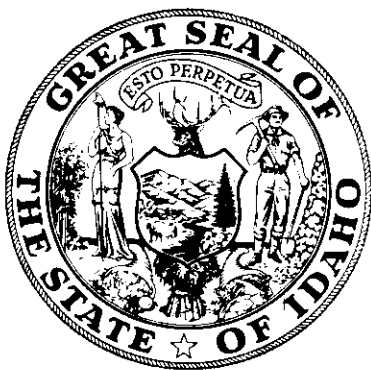

ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION

of

SIMPLOT INTERNATIONAL, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Article of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is:

SIMPLOT INTERNATIONAL, INC.

SECOND: The following amendment of the Articles of Incorporation was adopted by the Shareholders of the corporation on August 26, 1983, in the manner prescribed by the Idaho Business Corporation Act:

Article Fourth of the Articles of Incorporation is amended to read:

"FOURTH: The authorized capital of the corporation is Five Million Dollars (\$5,000,000.00). The aggregate number of shares which the corporation shall have authority to issue is Five Thousand (5,000), each having a par value of One Thousand and no/100 (\$1,000.00) Dollars per share. The stock of this Corporation shall not be subject to assessment. "

THIRD: The foregoing amendment was adopted by the Shareholders of the corporation for the purpose of increasing the authorized capital of the corporation from One Million Dollars to Five Million Dollars by increasing the number of shares authorized from One Thousand shares to Five Thousand shares, without changing the par value of each share.

FOURTH: The number of shares of the corporation outstanding at the time of such adoption was Ten; and the number of shares entitled to vote thereon was Ten.

FIFTH: The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:

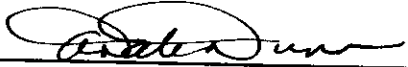

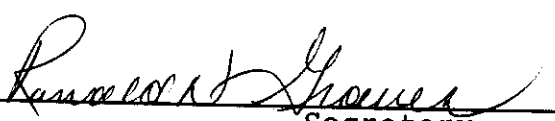

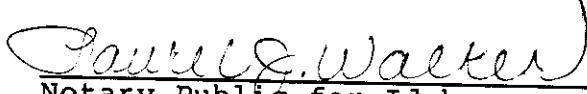
