tion under the laws of the State of Minnesota, and to that end have adopted

Article I.

and signed the following articles of incorporation:

Section 1. The name of this corporation shall be PAYETTE LUMBER & MANUFACTURING COMPANY.

Section 2. The general nature of its business shall be buying, owning, improving, selling, leasing, holding and dealing in lands, tenements, and hereditaments, real, mixed and personal estate and property, timber and all the products of timber, and buying and selling the same; carrying on and conducting a general logging, lumber and manufacturing business; erecting, buying, selling and operating saw mills, shingle mills, planing mills and all other mills and factories; establishing, operating, buying and selling lumber yards, clearing out and improving rivers and streams; driving, catching, booming, sorting, rafting, brailing, towing, holding and delivering logs, lumber and other timber products; building, equipping and managing water flumes for the transportation of wood and lumber; constructing canals and irrigating ditches; to purchase, subscribe for, deal in and hold the stock of other corporations to such an extent as may be permitted or allowed by the laws of the State of Minnesota; and to mortgage, bond or incumber any or all of its property, real and personal, in such sums and amounts and at such times and upon such terms as the corporation may find necessary or deem expedient; mining, smelting or manufacturing iron, copper or other minerals or for producing the precious metals; and to conduct and carry on any kind of manufacturing, lumbering, agricultural, mechanical, mercantile, chemical, transportation or other lawful business.

Article III.

Section 1. The capital stock of said corporation shall be Five Hundred Thousand Dollars, divided into five thousand shares of One Hundred Dollars each.

Section 2. Said stock shall be paid in as called for by the Board of Directors of said corporation.

Article IV.

Section 1. The highest amount of indebtedness or liability to which said corporation shall at any time be subject shall be Five Hundred Thousand Dollars.

Article V.

Section 1. The names and places of residence of the persons forming said corporation are as follows: A.E.Macartney, Frank Frei, and Lloyd Nesbit, all residents of St.Paul, Minnesota.

Article VI.

Section 1. The names of the first Board of Directors of said corporation are as follows: William Musser, Henry Turrish, R.D.Musser, F.W.Kehl and C.A.Weyerhaeuser.

Section 2. The government of said corporation and the management of its affairs shall be vested in a Boardof five directors and in a President, Vice-President, Secretary and Treasurer.

Section 3. The officers of said corporation shall be chosen from the Directors, and one person may hold more than one office.

Section 4. The amual meeting of the stockholders of said corporation for the election of Directors, and the transaction of such

other business as may properly come before them, shall be held at the office of the corporation in St.Paul, Minnesota, on the second Tuesday in May in each year, commencing with the year 1903, at 10 o'clock in the forenoon. Other meetings of the stockholders of said corporation shall be held at such times as the by-laws of said corporation may provide.

Section 5. The annual meeting of the Board of Directors of said corporation for the election of officers and the transaction of such other business as may properly come before them, shall be held at the said office of said corporation on the second Tuesday in May in each year, commencing with the year 1903, and immediately after the adjournment of the meeting of the stockholders. The Board of Directors may hold such other meetings as the by-laws of said corporation may provide.

Section 6. The Directors of such corporation shall be elected by the stockholders from among their number, at the annual meeting in each year, and the officers of said corporation shall be elected by the Board of Directors from among the Directors at the annual meeting of the Directors in each year.

Section 7. William Musser shall be the first President of said corporation, Henray Turrish, shall be its first Vice President, F.W.Kehl shall be its first Secretary, and R.D.Musser shall be its first Treasurer. Said officers shall serve until their successors are elected and qualified.

Section 8. Any vacancy in any of said offices or in said Board of Directors shall be filled by the Board of Directors for the unexpired term.
