ARTICLES OF INCORPORATION

OF

WISE-BUY CORPORATION

The undersigned, acting as incorporators, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be Wise-Buy Corporation.

ARTICLE II

The purposes for which said corporation is formed are:

- A. To engage in the business of operating a retail grocery store.
- B. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
