and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 29, Idaho Code, Annotated.

ARTICLES OF INCORPORATION OF THE  
IDAHO STATE NURSES ASSOCIATION.

THIS IS TO CERTIFY THAT: Whereas the Idaho State Nurses Association has been functioning as an unincorporated, benevolent and fraternal association, now recognizing the advantages of being incorporated under the laws of the State of Idaho, has called this meeting for the purpose of, among other things, electing officers, directors, adopting Articles of Incorporation, and doing all things necessary to effect a corporation in accordance with the laws of the State of Idaho, and in accordance with the rules, regulations and discipline of this association, and at a meeting duly held for such purpose a majority of the members voted in favor of forming a corporation, and the undersigned, being natural persons of full age and citizens of the United States, in order to form a corporation for the purposes hereinafter stated, and under and pursuant to the provisions of the laws of the State of Idaho in such cases made and provided, do hereby certify:

FIRST

The name of the corporation is IDAHO STATE NURSES ASSOCIATION, INCORPORATED

SECOND

The purposes of this association are and shall be to promote the professional and educational advancement of nurses in every way; to elevate the standard of nursing education; to establish and maintain a code of ethics among nurses, to distribute relief among such nurses as may become ill, disabled or destitute; to disseminate information on the subject of nursing, by publications in official periodicals or otherwise;

to bring into communication with each other various nurses and associations of nurses throughout the State of Idaho; for such purposes to accumulate funds; to acquire, hold and dispose of property, both real and personal.

THIRD

That the principal place of business shall be Boise, Idaho, but meetings of the members or directors may be held at such other place or places as may be chosen by the members or the Board of Directors from time to time.

FOURTH

That the term for which said corporation is to exist is fifty years.

FIFTH

The Board of Directors shall consist of the President, First Vice-President, Second Vice-President, Secretary, Treasurer and four Directors at Large. The President, Second Vice-President, Treasurer and two Directors at Large shall hold office for one year, and thereafter shall be elected at the annual election in the even numbered year and shall hold office for two years. The First Vice-President, Secretary and two Directors at Large shall hold office for two years, and thereafter shall be elected at the annual election in the odd numbered year and hold office for two years. All officers shall hold office until their successors are elected and qualified.
