Articles of incorporation of the undersigned, a majority of whom are citizens of the United States, desire to form a Non-Profit Corporation under the Non-Profit Corporate Law of the State of Idaho, do hereby certify:

## ARTICLE I CONSTITUTION

The name of this corporation shall be LIVING HOPE CHURCH, INC. OF THE CITY OF BOISE, STATE OF IDAHO, ADA COUNTY.

## ARTICLE II PURPOSE

The purpose of this church shall be:

- A. To establish and maintain a place of worship.
- B. To conduct under the guidance of the Holy Scriptures the work of evangelizing both home and foreign field in obedience to the command of the Lord Jesus and His apostles.
- C. In connection therewith, or incidental thereto, it shall have the right to purchase or acquire by gift, bequest, or otherwise, either directly or as a trustee, and to own, hold in trust, use, sell, convey, or otherwise dispose of any real estate or chattels as may be necessary for the furtherance of its purposes.
