ARTICLES OF INCORPORATION OF NATE MORGAN JEWELERS OF POCATELLO, INC.

We, the undersigned, being of majority age, citizens of the United States and residents of the State of Idaho, do hereby, voluntarily, associate ourselves together for the purpose of forming a corporation under and by virtue of the laws of the State of Idaho, and for that purpose do adopt the following Articles of Incorporation:

Ι

The name of this corporation shall be the "NATE MORGAN JEWELERS OF POCATELLO, INC."

II

The purposes of this corporation shall be:

To carry on business as jewelers, gold and silversmiths, dealers in china, curiosities, articles of virtu, coins, medals, bullion, and precious stones, and as manufacturers of and dealers in gold and silver plate, plated articles, watches, clocks, chronometers, and optical and scientific instruments and applicanes of every description, and as bankers, commission agents, and general merchants.

To acquire all of the property and assets of the firm of Nate Morgan Jewelers, Inc. and to carry on the business of said firm; and to have and exercise all powers and do all acts necessary and desireable in order to carry on the business heretofore carried on by the firm of Nate Morgan Jewelers, Inc.

To buy, sell, lease, mortgage, and exchange any and all real and personal property, that will be necessary, advantageous or proper in the conduct of its business.

To do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things incidental or appurtenant to or growing out of or connected with the aforesaid objects or purposes or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized.

To have any and all powers granted or authorized by the State of Idaho, and of the United States and especially all powers and rights granted by Section 30-114, Idaho Code.

III.

The duration of this corporation shall be perpetual.

IV.

The location and postoffice address of the principal place of business and the registered address of this corporation shall be 125 South Main, Pocatello, Bannock County, Idaho.

The capitalization of this corporation shall be Twenty-five thousand and no/100 (\$25,000.00) Dollars. The total number of shares at their par value shall be Two hundred fifty (250) shares at a par value of One Hundred and no/100 (\$100.00) Dollars per share. All shares shall be of the same class, value, and have the same voting and other rights.
