SECOND AMENDMENT TO ARTICLES OF INCORPORATION

The undersigned, the directors and the shareholders of the common stock of Alpine Archery, Incorporated, a corporation under the Idaho Business Corporation Act, adopt the following amendments to the Articles of Incorporation of said corporation:

FIRST: The class of preferred stock of the corporation, all of which is presently held in the treasury of the corporation, shall be eliminated and no longer be valid, authorized stock of the corporation.

SECOND: The aggregate number of shares of common stock which the corporation shall be authorized to issue shall be increased from the present two hundred shares to four hundred shares. All of said common stock shall continue to have a par value of \$1.00 per share.
