ARTICLES OF AMENDMENT
(Non-profit)

To the Secretary of the State of Idaho

Pursuant to Title 30, Chapter 3, Idaho Code, the undersigned non-profit corporation amends its articles of incorporation as follows:

1. The name of the corporation is Lost and Found Campus Ministry Inc.
2. The text of each amendment is as follows:

Article 1: The name of the corporation shall be changed to Treasure Valley Youth Alliance, Inc.

Article 4: The location of the organization is the city of Boise, Ada County, and in the state of Idaho. The address of the initial registered agent at this address is Jason W. Kaat.

Article 5: The specific purposes and operation for this corporation are:

- A. Develop and implement strategies to evangelize and disciple students on every Middle High, Junior High and Senior High Campus in the Treasure Valley including, but not limited to, Christian Education Release Time campus ministries and ACTS Revolution Campus Clubs.
- B. Partner and promote area youth-worker prayer meetings that will encourage youth workers to develop personal holiness.
- C. Provide and promote local training opportunities that equip, empower, and encourage youth workers to build stronger youth ministries in our area.
- D. Promote and develop area-wide events that provide opportunities for evangelism and discipleship for all youth ministries and churches in our area.
- E. Produce publications that will be a resource to all local youth ministries in our area.
- F. For charitable, religious, educational, or scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 2001, as amended from time to time, including for such purposes, the making of and distributions to organizations that qualify as exempt under section 501(c)(3), providing those purposes are consistent with those set out in paragraph A-E, supra.
- G. To exercise all powers granted by law necessary and proper to carry out the following purposes, including, but not limited to: the power to accept donations of money, property (whether real or personal), or any other things of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefore, may not at that time lawfully carry on or do.

Article 8: The Board of Directors is amended to include the following change in the Board of Directors:
