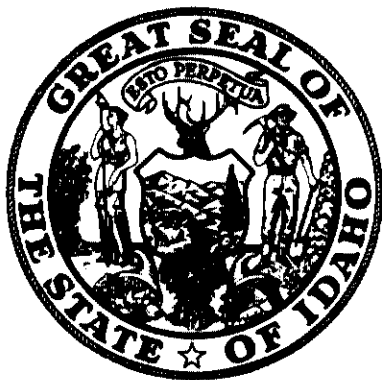
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is ROLLY, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: to contract for and prepare real estate appraisals and the transaction of any and all other lawful business for which corporations may be incorporated within the State of Idaho.

FOURTH: Capital stock shall be FIFTY THOUSAND DOLLARS. The aggregate number of shares which the corporation shall have authority to issue is fifty thousand (50,000) shares at a par value of one dollar (\$1.00).

FIFTH: Provisions for the regulation of the internal affairs of the corporation are as governed by the By-Laws.

SIXTH: There shall be a restriction on the transfer of any interest whatsoever of the stock of this Corporation. Restriction on the transfer of interest shall be governed by provisions as set forth in the By-Laws.

SEVENTH: The address of the initial registered office of the corporation is 131 East Cindy, Inkom, Idaho, 83245, and the name of its initial registered agent at such address is Roland Hull.

EIGHTH: The number of directors constituting the initial board of directors of the corporation is six (6), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
