The undersigned, for the purposes of forming a close corporation pursuant to the provisions of the US Internal Revenue Code and the Idaho State Business Corporations Act, does hereby make, subscribe, acknowledge and file with the Idaho Department of the Secretary of State this instrument for that purpose, as follows:

- 1. The name of the Corporation shall be:

- 8. The Corporation's Board of Directors and Shareholders shall adopt, amend or repeal the By-Laws of the Corporation.

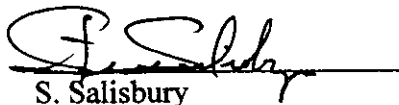
