



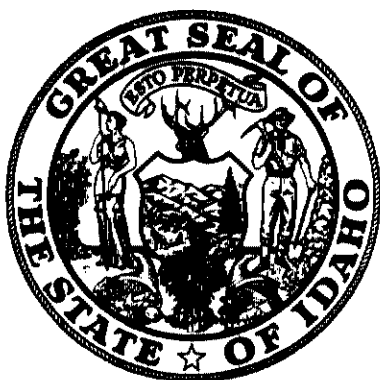
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION 91 SEP 11 AM 8 39
OF
CJ BUILDING PRODUCTS, INC.

The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following articles of incorporation.

ARTICLE ONE: The name of the corporation is CJ BUILDING PRODUCTS, INC.

ARTICLE TWO: The period of duration of the corporation is perpetual.

ARTICLE THREE: The purposes for which the corporation is organized are (1) to sell building materials wholesale, and (2) to engage in any and all lawful businesses for which a corporation may be organized under Idaho's General Business Corporation Act.

ARTICLE FOUR: The aggregate number of shares that the corporation is authorized to issue is One Thousand (1,000). There will be only one class of shares, which will be without par value.

ARTICLE FIVE: There is no provision for the denying of preemptive rights to the shareholders.

ARTICLE SIX: There are no provisions for the regulation of the internal affairs of the corporation.

ARTICLE SEVEN: The name and address of the initial registered agent and the registered office of the corporation are:
