**ARTICLES OF INCORPORATION  
OF  
ROOTS LIMITED**

KNOW ALL MEN BY THESE PRESENTS: That Richard J. Hallisy, being over the age of eighteen (18) years, and for the purpose of forming a non-profit corporation under the Idaho Non-Profit Corporation Act, hereby certifies and adopts, in duplicate, the following Articles of Incorporation.

**ARTICLE I.**

The name of the corporation shall be "Roots Limited".

**ARTICLE II.**

The corporation is a non-profit corporation.

**ARTICLE III.**

The period of duration of the corporation shall be perpetual.

**ARTICLE IV.**

The purpose for which the corporation is organized is the conduct of a commercial, industrial and trade association.

**ARTICLE V.**

The corporation shall have one class of members. Any forest products entity or any labor union representing forest products industry workers is eligible for membership. Admission to membership shall be by a vote of the board of trustees.

ARTICLE VI.

The address of the initial registered office of the corporation is c/o Long Machinery, Highway 12 East, P. O. Box 1900, Lewiston, Idaho 83501, and the name of the initial registered agent at such address is Lonnie Cavanaugh.
