



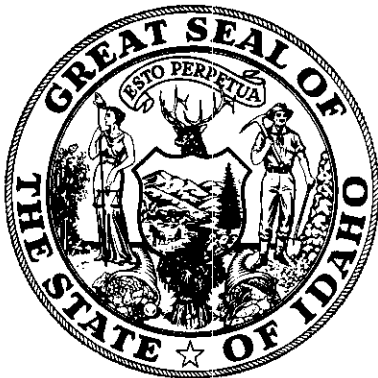
**CERTIFICATE OF INCORPORATION

WE, THE UNDERSIGNED, Hereby incorporate ourselves under  
the Idaho Business Corporation Act [§§30-1-1ff. I.C.].

ARTICLE I

The name of the corporation shall be SNARR KYNASTON AND  
ASSOCIATES, INC.

ARTICLE II

The duration of the corporation shall be perpetual.

ARTICLE III

The purpose of the corporation shall be to transact any  
lawful business for which corporations may be organized under such  
act.

ARTICLE IV

The aggregate number of shares of capital stock author-  
ized shall be 10,000, with an aggregate par value of \$10,000, such  
shares to be of the same class and of \$1 par value each.

ARTICLE V


The address of the initial registered office of the
