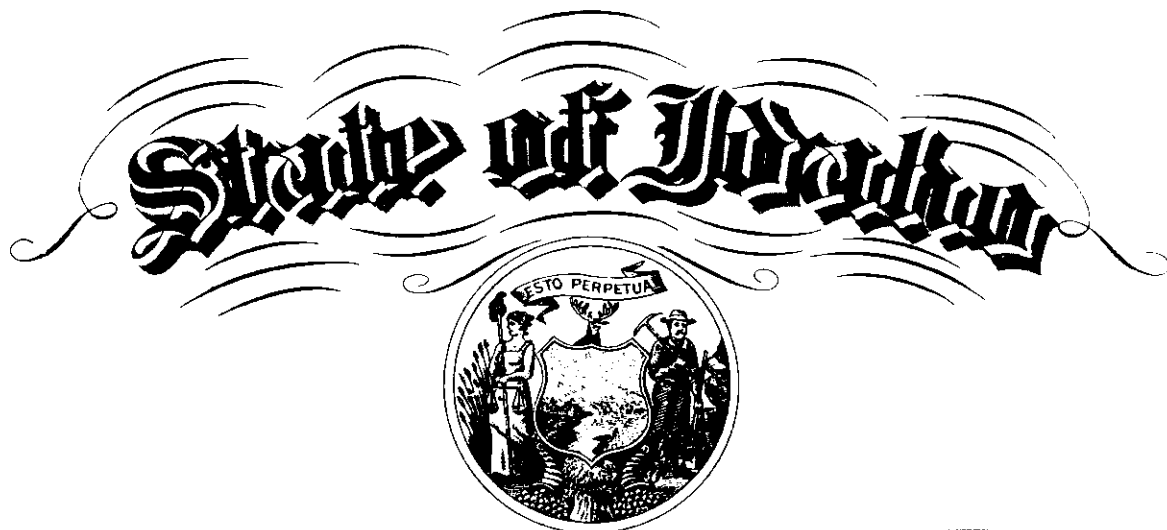

ARTICLES OF INCORPORATION
OF
LARRY LEE TRUMP TRUST II, INC.,

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, all of whom are citizens of the United States of America, residents of the State of Idaho, and of legal age, have voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and have hereby agreed:

I.

The name of the said corporation shall be "LARRY LEE TRUMP TRUST II, INC."

II.

The duration of the corporation shall be perpetual.

III.

The location of the principal office of the registered office of the corporation in the State of Idaho shall be Pocatello, Idaho.

IV.

The amount of the authorized capital stock of the corporation shall be Larry Thompson Dollars, (\$50,000.00) divided into five hundred (500) shares of common stock of the par value of one hundred Dollars, (\$100.00) each share. All of the stock shall have the same powers and voting rights and shall be negotiable for any purpose whatsoever.

V.
