of Idaho hereby associate ourselves  
together for the purpose of creating  
a corporation under and by virtue  
of the Laws of the Territory of Idaho  
do hereby certify

First. The corporate name of this  
Company is and shall be the Wood  
River Land and Irrigation Com-  
pany.

Second. The object for which this  
Company is formed, is to acquire  
hold, improve, sell, lease, and con-  
vey real property; to cultivate  
land and dispose of the products  
thereof; to construct water ditches  
irrigating canals, to sell the water  
and sell or lease the rights thereof  
in the Territory of Idaho

Third. The amount of the Capital  
Stock of this company shall be five  
hundred shares, each of the par value  
of one hundred dollars, making the  
aggregate sum of Fifty Thousand  
Dollars


Fourth. The existence of this Company shall continue for the term of twenty years.

Fifth. The number of Trustees who shall manage the business affairs of said Company shall consist of six (6) persons and the Incorporators herein before named shall be the Trustees of said Company for the period of three months from and after the date of this organization. And there shall be an annual meeting of the Stockholders of this Company for the election of Trustees each year thereafter, at such time as the By Laws of said Company shall prescribe.

Sixth. The principal place of business of said Company shall be at Healy, Blaine County, Idaho.

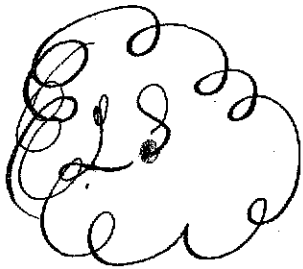
