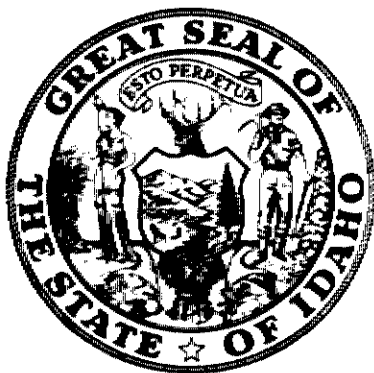

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is R & P, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on April 8, 1988, in the manner prescribed by the Idaho Business Corporation Act:

FIRST: The name of the corporation is B & A, Inc.

SEVENTH: The address of the initial registered office of the corporation is and the name of its registered agent at such address is William H. Bernard, 10190 Roan Meadows Drive, Boise, Idaho 83709.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was eighteen (18); and the number of shares entitled to vote thereon was eighteen (18).
