ARTICLES OF AMENDMENT

for ProPaint and Decorating, Inc.

The undersigned Incorporator being the Sole Incorporator the Corporation hereby adopts the following Amendment to the original Articles of Incorporation of the Corporation in compliance with Idaho Code Section 30-1-61, as follows:

- The name of the Corporation is ProPaint and Decorating, (a) Inc.
