We further certify that notice of said proposed meeting of the stockholders was published in the Mullen Progress, a newspaper of general circulation published at the village of Mullen in Shoshone County, State of Idaho, the principal place of business of said corporation, once each week for at least thirty days preceding the date of said meeting, to-wit:- from July 27th, 1918, to August 3rd, 1918, which said notice contained a statement of the amount to which it was proposed to increase said capital stock and a copy of which said notice is hereto attached and made a part of this certificate.

That pursuant to said notice a meeting of the stockholders of said company was held at the office of the company in the Victor Hotel at Mullen in Shoshone County,

Idaho, on the 4th day of September, 1915, at 2:00 o'clock
in the afternoon of said day, at which said meeting there
was present or represented by proxies stockholders holding
865,902 shares of the capital stock of said corporation,
being more than two thirds of the entire capital stock of
said corporation.

That at said meeting it was resolved by the affir-
mative vote of 865,902 shares of the capital stock of
said corporation being more than two thirds of the entire
capital stock thereof to increase the capital stock of said
corporation from \$1,250,000 to \$1,500,000 said capital stock
so increased to be divided into 1,500,000 shares of the par
value of \$1.00 per share; and the chairman and secretary
of said meeting were authorized and empowered to make, sign,
witness and properly file a certificate to increase the capital
stock as required by the laws of the State of Idaho.
