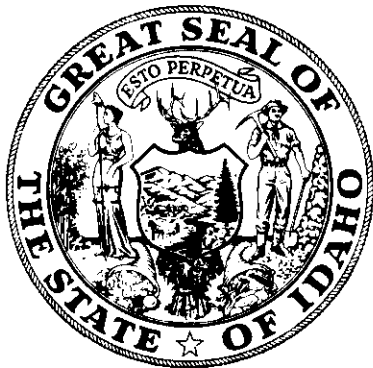

ARTICLES OF AMENDMENT

OF

STATE

RENAISSANCE ACADEMY OF THE ARTS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, do hereby amend the Articles of Incorporation of Renaissance Academy of the Arts, Inc., as follows:

(1) That paragraph No. 4 of the Articles of Incorporation of Renaissance Academy of the Arts, Inc., be deleted and the following new paragraph 4 be substituted therefor:

"(4) The purposes for which the corporation is organized are as follows:

(a) This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of §501(C)(3) of the Internal Revenue Code. Said purposes shall include the furtherance of the arts through teaching and public performance and distributions to organizations that qualify as exempt organizations under §501(C)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law).

1 (b) To do any or all other acts or things in  
2 any manner connected with or necessary, incidental,  
3 convenient, or auxiliary to any of the purposes hereinbefore  
4 enumerated, or calculated, directly or indirectly to promote  
5 the interests of the corporation and to carry out its  
6 purpose."


7 (2) Said amendment was adopted by a resolution of the  
8 Board of Directors on September 1, 1983.

9 (3) There are no members or shareholders.

10 (4) The vote by the Board of Directors was unanimous  
11 in favor of said amendment.
