ARTICLES OF INCORPORATION

Know all men by these presents: That we the undersigned, have this day voluntarily associated ourselves together for the purpose of incorporating a religious corporation under the laws of the State of Idaho, and in pursuance of the purposes for which we have been elected, as hereinafter set forth, we certify:

I

That said religious corporation is to be known as the Elk City Community Church of Elk City, Idaho, Incorporated.

II

As a church we are a non-profit religious organization, deriving all monies from donations, none of which is invested.

III

That the term for which this corporation is to exist is perpetual from and after the date of its incorporation.

IV

That the objects for which this incorporation is formed are to establish and maintain a church in the City of Elk City, Idaho County, Idaho and in connection therewith to acquire and own a church building, a parsonage, and any other necessary property and buildings suitable and customary for the purpose of holding public worship and religious training, including, but is not limited to, the following:
