upon whom process issued by authority of, or under any law of the State of Idaho, may be served, as provided  
by the Constitution and laws of said State of Idaho.

desiring and intending to conform in all respects to the Constitution and laws of said State, and to avail itself  
of the rights, privileges and immunities guaranteed by said Constitution and laws, does hereby accept the provis-  
ions of the Constitution of the State of Idaho for all the intents and purposes contemplated by the provisions there-  
of, relating to such acceptance by other than municipal corporations. (Article XI, Section 7, Constitution of  
Idaho.)
