# ARTICLES OF INCORPORATION SAWTOOTH ARTISANS' GUILD INCORPORATED

We, the undersigned residents of the State of Idaho, being 18 years of age or more, do hereby associate ourselves together for the purpose of forming a non-profit corporation under the Statutes of the State of Idaho.

#### ARTICLE ONE NAME, NON PROFIT STATEMENT, AND LOCATION

The name of the corporation shall be SAWTOOTH ARTISANS' GUIED INCORPORATED, the corporation shall be non-profit, and its location shall be Box 107, City of Stanley, County of Custer, State of Idaho.

### ARTICLE TWO DURATION

The period of duration of this non-profit corporation shall be perpetual.

#### ARTICLE THREE PURPOSE CLAUSE

The business and purpose of this corporation shall be to bring Sawtooth Valley-Stanley Basin artists and crafts people together for mutual support, to provide a commercial outlet for their artwork, and advance the establishment of artistic endeavors in the Sawtooth Valley-Stanley Basin area.

### ARTICLE FOUR NONSTOCK CORPORATION

The corporation shall be nonstock, and no dividends of pecuniary profits shall be declared or paid to the members thereof.

### ARTICLE FIVE DIRECTORS

The number of directors constituting the initial board of directors of the corporation is THREE, and the names and addresses of the persons who are to serve as initial directors are as follows:

### ARTICLE SIX MANAGEMENT OF CORPORATION AND ELECTION OF DIRECTORS

Management of the corporation shall be directed and controlled by the board of directors elected annually by a vote of the total membership of the corporation present.

#### ARTICLE SEVEN INITIAL REGISTERED AGENT

The street address of the initial registered office is HC 64 Box 9900 HWY 75, Stanley, Idaho 83278, and the initial registered agent at that address is Lynn Karstaedt.

### ARTILCE EIGHT CORPORATE OFFICERS AND THEIR FUNCTION

The general officers of the corporation shall be President, Secretary, and Treasurer/Vice President.

The principal duties of the president are to preside over both board amd membership meetings. The president will perform all duties as prescribed by the board. He/She may sign with the treasurer any deeds, trusts, bonds, contracts, and checks which the board authorizes.

The principal duties of the secretary are to attend and record the minutes of all meetings (board and membership). He/She will be responsible for all written correspondence. Along with the treasurer he/she may sign any deeds, bonds, contracts, and checks which the board authorizes.

The principal duties of the treasurer/vice president are to keep accurate financial records and report the financial status of the organization when requested. He/She will oversee the financial management of the commercial outlet store. The treasurer may sign with the president any deeds, bonds, contracts, and checks which the board authorizes. The treasurer will preside over meetings in the absence of the president.

### ARTICLE NINE ELECTION OF OFFICERS

The officers shall be elected by the members of the corporation.

### ARTICLE TEN MEMBERSHIP REQUIREMENTS

The membership is limited to residents (including summer residents) of the Sawtooth Valley-Stanley Basin area interested in the business, artistic, and social aims of the organization.
