2. That at a duly held meeting of the board of directors of  
the corporation, held at 450 North Idaho Street, Wendell, Idaho  
83355, on December 27, 1994, the board adopted the following  
resolution approving the following amendments to the Articles of

desire to amend the articles of incorporation to provide that the  
corporation shall have the authority to issued 20,000 shares of  
stock, all of one class, \$16.50 par value.

**RESOLVED**, that the articles of incorporation be, and

adding thereto the following new article 3, so that the articles  
of incorporation shall read as listed below.

**CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION  
BERT HARBAUGH MOTORS CORPORATION**

1. The name of the corporation is BERT HARBAUGH MOTORS, INC.
2. The period of its duration is perpetual.
3. Its purpose is to transact the business of automobile, marine and RV sales and repairs and all other business not forbidden by law.
4. It shall have authority to issue 20,000 shares of stock, all of one class, \$16.50 par value.
5. The address of its initial registered office is 450 North Idaho Street, Wendell, Idaho 83355. The name of its initial registered agent is BERT HARBAUGH.
6. The number of directors constituting its initial Board of Directors is two, whose names and addresses are:
