ARTICLES OF AMENDMENT SECRETARY OF STATE

AMEND AND RESTATE

THE

ARTICLES OF INCORPORATION

OF

FIRST ASSEMBLY OF GOD, INC.,

OF LEWISTON, IDAHO

Pursuant to the provisions of Section 30-327 of the Idaho
Nonprofit Corporation Act, the undersigned corporation adopts the
following Articles of Amendment to Amend and Restate its Articles
of Incorporation (the "Articles"). The following Articles of
Amendment were adopted pursuant to a duly noticed meeting of the
members of the corporation held on the 13th day of February,
1983, at which a quorum of the members of the corporation were
present. At such meeting the following Articles of Amendment
were adopted by at least a majority of the members present who
were entitled to vote thereon. The following Articles of
Amendment amend each and every provision of the former Articles
of Incorporation and replace and supersede the former Articles of
Incorporation in their entirety to read as set forth herein:

ARTICLE I

. NAME OF CORPORATION

The name of the corporation is First Assembly of God, Inc.,

of Lewiston, Idaho, hereinafter and hereinbefore referred to as (the "corporation").

ARTICLE II

STATEMENT OF NONPROFIT STATUS

The corporation is and shall be non profit corporation.

ARTICLE III

TERM

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE IV

PURPOSE AND POWERS OF THE CORPORATION

This corporation does not contemplate pecuniary gain or profit to the members thereof, and the specific purposes for which it is formed shall be to carry out any lawful activity of a religious, charitable, benevolent, eleemosynary, patriotic, civic, missionary and educational character, including without limitation to:

- 4.1 Exercise all of the powers and privileges and perform all of the duties and obligations of the corporation as set forth in the Bylaws of the corporation and as the same may be amended and supplemented from time to time as therein provided.
 - 4.2 Acquire (by gift, purchase or otherwise), own,

hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the corporation under the limitations imposed by the Bylaws of the corporation; provided, that real property shall not be sold, or leased for a term in excess of one (1) year, unless consented to by a majority of the members present at any meeting called for such purpose.

- 4.3 Borrow money, and with the assent of a majority of the members present at any meeting call for such purpose, mortgage, pledge, deed in trust, hypothecate or otherwise transfer any or all real or personal property of the corporation as security for money borrowed or debts incurred;
- 4.4 Have and to exercise any and all powers, rights and privileges which a corporation organized under the Non-Profit Corporation Law of the State of Idaho by law may now or hereafter have or exercise, subject only to limitations contained in the Bylaws and the amendments thereto.

ARTICLE V

MEMBERSHIP

This corporation shall have members. The membership of the corporation shall consist of those persons who desire to be members of the corporation, who hold to the Articles of Faith of

the First Assembly of God, Inc. of Lewiston, Idaho as set forth in the Bylaws of the corporation and the amendments thereto, who otherwise meet or have satisfied membership requirements as set forth in the Bylaws and amendments thereto, and who are certified by the Board of Directors to be members in good standing. A certificate by the Board of Directors that a person is a member in good standing and/or setting forth the members of the corporation shall be conclusive as to the membership of the Corporation as to third parties relying theron.

ARTICLE VI

VOTING MEMBERS - VOTING RIGHTS

All members who have obtained the age of eighteen (18) years and who otherwise meet the qualifications to be voting members as set forth in the Bylaws and amendments thereto shall be voting members. All voting members shall be entitled to one (1) vote on all matters that come before the members for vote. A certificate by the Board of Directors that a person is a voting member and/or setting forth the voting members of the Corporation shall be conclusive as to the voting members of the Corporation as to the third parties relying thereon.

ARTICLE VII

BOARD OF DIRECTORS

The affairs of this corporation shall be managed by a board of seven (7) directors ("Board of Directors") who shall be mem-
