KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of legal age, and citizens of the United States, do hereby associate ourselves together with the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

I.

The name of the corporation shall be M. BEST SECURITY CONSULTANT, INC.

II.

The nature, objects and purposes for which this corporation

is formed shall be:

a. Consulting services relating to personal protection, both for businesses and individuals.

b. To acquire, buy, own, hold, sell, exchange, let or lease personal property and real property within the State of Idaho, or outside of the State of Idaho.

c. To borrow money for the purposes of this corporation, to issue bonds, notes and debentures and other evidences of indebtedness therefore, and to secure the same by mortgage or pledge of personal property, including the income of said corporation, or by mortgage of real property, executed in trust or otherwise. All or any portion of the real or personal property of the corporation may be pledged, mortgaged or hypothecated.

d. To build any or all buildings, structures, warehouses or erect the same involved in the said business, building materials, fuel and to acquire the same by purchase, lease or otherwise.
