AMENDMENT TO

ARTICLES OF INCORPORATION

The undersigned, acting as Chairman of the Board of Directors of a corporation under the Idaho Business Corporations Act, adopts the following amendments to the Articles of Incorporation for such corporation, effective as of the date hereof:

FIRST:

The name of the corporation is: bankcda.

SECOND:

The following amendments are hereby adopted:

A. The Third Paragraph of Article VI is amended to read as follows: "The number of Directors constituting the initial Board of Directors of the Corporation is eleven (11), and the names and addresses of the persons who are to serve as Directors until the first meeting of shareholders or until their successors are elected and shall qualify are:

B. The first sentence of Article V shall be amended to read as follows: "The amount of capital stock of the Corporation shall be TWENTY-FIVE MILLION DOLLARS (\$25,000,000) divided into 5,000,000 shares of common stock with a par value of \$5.00 each, but said capital stock may be increased or decreased from time to time, in accordance with the provisions of the laws of the State of Idaho."
