The undersigned, being the officers and all the shareholders PaulMark, Inc., an Idaho Business Corporation, hereby unanimously adopt the following Restated Articles of Incorporation for such corporation pursuant to Idaho Code §30-1-1007:

- 1. **NAME:** The name of the corporation is PaulMark, Inc.
- 2. **DURATION:** The period of its duration is perpetual.
- 3. **PROFIT**: This is a for profit corporation.
- 4. **PURPOSES:** The purpose or purposes for which the corporation is organized is to engage in the business of purchasing, marketing, selling, and distributing bear, wine and other alcoholic and non-alcoholic beverages and do all things incidental thereto and for the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, as the same from time to time shall be amended.
