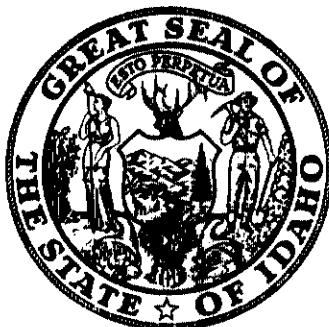
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is SAWTOOTH VACUUM & WATER CONDITIONERS, INCORPORATED.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized, is to engage in the business of selling and servicing vacuum cleaners and water conditioners, but is not limited thereto.

The general purpose of the incorporation shall be to engage in all business activities authorized and permitted under the laws of the State of Idaho. The business practices of the corporation shall not be limited to the specific purposes set forth herein.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) shares, with a par value of \$2.00 per share.

FIFTH: There shall be no provisions denying preemptive rights in these Articles of Incorporation.

SIXTH: Provisions for the regulation of the internal affairs of the corporation shall be set forth in the By-Laws and are specifically excluded from these Articles of Incorporation.

SEVENTH: The address of the initial registered office of the corporation is 329 Addison Avenue West, Twin Falls, Idaho 83301, telephone number (208) 733-2504, and the name of its initial registered agent at such address is Robert Franklin Greenwood.

EIGHTH: The number of directors constituting the initial board of directors of the corporation is two (2), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:

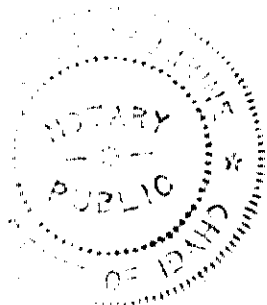
