KNOW ALL MEN BY THESE PRESENTS: that I, the undersigned, a natural person of full age, citizen of the United States of America and resident of the State of Idaho, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation shall be MOUNTAIN STATES MAN-UFACTURING, INC.

The term for which said corporation shall exist shall be in perpetuity.

III.
