The Registrar further certifies that on the same 1st January 1985 the said company was re-registered under The Barclays Bank Act 1984 as a public company.

The Registrar also certifies that according to the documents on the file of the company, the situation of the registered office is I CHURCHILL PLACE, LONDON £14 5HP.

Dear Mr. Kaplan:

Thank you for your letter dated May 1, 2015 and the additional information you provided to us in an e-mail dated May 18, 2015.

We have reviewed the information you submitted in your letter of May 1, 2015, as well as the information set forth in your May 18, 2015 e-mail. Based on that information, it is our opinion that Barclays Bank PLC is not required to obtain a charter issued pursuant to the Idaho International Banking Act, Idaho Code § 26-1702, et seq., nor a license issued pursuant to the Idaho Residential Mortgage Practices Act, Idaho Code § 26-31-101, et seq., as a prerequisite to conducting commercial lending activities in the State of Idaho.

Further, the Idaho Department of Finance does not object to Barclays Bank PLC's use of the word "bank" in its name in its commercial lending activities in Idaho. The Idaho Bank Act, at Idaho Code § 26-1202, prohibits any person, other than a national bank, not authorized to operate as a bank under the Act, to advertise or use as part of its company name the word "bank," "banker," or any other words of similar import. The Idaho Bank Act does not authorize the Director of the Idaho Department of Finance to waive the requirements of the law. Under the circumstances presented in this matter, however, we do not believe your proposed use of the name Barclays Bank PLC in Idaho is misleading to the public and therefore, we do not object to it. While the Department does not intend to pursue an action under this statute, it is possible that another agency may do so. However, we believe the likelihood is slight.
