

ARTICLES OF INCORPORATION OF THE
SHAMROCK MINING COMPANY, LTD.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation, under the laws of the state of Idaho.

And we hereby certify: First. That the name of said Corporation is the SHAMROCK MINING COMPANY, LIMITED.

Second. That the purposes for which said Corporation is formed are to carry on a general mining business; locating, bonding, purchasing and selling mines and mining claims; erecting, maintaining, operating and conducting mills and mining plants, and mining and milling gold and other metals, and to all things necessary to properly and successfully operate and conduct the same.

Third. That the place where its principal business is to be transacted shall be the town of Hailey, Blaine county, State of Idaho, with a branch office at No. 52 Broadway, New York city, State of New York.

Fourth. That the term for which it is to exist is fifty years from and after the date of its incorporation.

Fifth. That the number of its Directors shall be seven, and the names and residences of those who are appointed Directors for the first year, and until the election and qualification of their successors are:
