ARTICLES OF INCORPORATION
OF
BONNER COUNTY SHORELINE PROPERTY OWNERS AND
TAXPAYERS PROTECTIVE ASSOCIATION, INC.

We, the undersigned persons of the age of 21 years or more, acting as incorporators of a corporation under the provisions of Title 30, Chapter 10 of the Idaho Code, adopt the following Articles of Incorporation for such corporation.

I.

The name of the corporation is the Bonner County Shoreline Property Owners and Taxpayers Protective Association, Inc.

II.

The period of its duration is perpetual.

III.

The purposes for which this corporation is organized are to form an association of owners of property in the waters and lands of Pend Oreille Lake drainage area in Idaho and to promote the sound and progressive development of the waters of said lake, its tributaries and lakeshore property; to protect established rights to the use of lakeshore property; to encourage development of lakeshore property, installation of navigational aids and all other developments that will improve the lake and enhance property values of contiguous property; to improve sanitation facilities and dispense with water pollution; to promote all forms of water safety, safety education, safety rules and regulations and enforcement thereof; to oppose discriminatory treatment of lakeshore or Lake Pend Oreille drainage area property owners by taxing or other public authority; and generally to take any and all action deemed advisable by the corporation to represent the common interests of the owners of property on Lake Pend Oreille and its drainages.

IV.

The conditions and regulation of membership and the rights and other privileges of the classes of members shall be determined and fixed by the By-Laws provided that the rights and interests of all members shall be equal; and no member can have or acquire a greater interest therein than any other member; the dues to be paid by each member and the procedure for terminating membership shall likewise be fixed by the By-Laws.

V.

The address of the registered office of the corporation is
323 N. Second Avenue , Sandpoint, Idaho.

VI.

The number of Directors of said Corporation shall be not less than seven (7) nor more than twenty-four (24), subject to the provisions of the By-Laws; and an Executive Committee of said Directors may be established by the By-Laws.
