ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF 91 JUL 5 AM 8 48  
MOSCOW HOSPITAL ASSOCIATION, INC.

Pursuant to § 30-327 of the Idaho Code for the State of Idaho, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation dated April 13, 1973:

I

The name of the corporation (prior to this amendment) is MOSCOW HOSPITAL ASSOCIATION, INC.
