

**CERTIFICATE OF CANCELLATION**

In accordance with the provisions of the Idaho Limited Partnership Act, Idaho Code §§ 53-201 et seq, the undersigned being all of the general and limited partners of the subject limited partnership, hereby state and set forth as follows:

1. The name of the limited partnership is THE CANUS-FCI LIMITED PARTNERSHIP, an Idaho limited partnership.

2. On the 29th day of September, 1980, the original Certificate of Limited Partnership for the subject limited partnership was filed with the Ada County Recorders Office, as Instrument No. 8046044, records of Ada County, Idaho, and on January 27, 1984 a certified copy of such certificate was, refiled with the Idaho Secretary of State as limited partnership No. L00577, records of the Idaho Secretary of State.

3. Effective June 1, 1986, the partnership was dissolved and shall no longer conduct any business except as necessary and expedient to wind up its affairs, dispose of its real property and other assets, and to liquidate and terminate the Partnership.

4. The effective date of cancellation of the Certificate of Limited Partnership shall be December 31, 1986 unless such effective date is extended by written extension of this Certificate of Cancellation executed by the General Partners and the Limited Partner and filed with the Idaho Secretary of State prior to the effective cancellation date set forth herein

5. Backward Inc., one of the general partners, shall be the sole General Partner with authority to act for the partnership as the liquidating partner under Idaho law and such General Partner shall consult with the Limited Partner as to all acts of the Partnership during the winding up and liquidation.

6. The real property and all other assets of the partnership not disposed of pursuant to the winding up and liquidation of the partnership shall be distributed to the Limited Partner in satisfaction of the obligations to the Limited Partner under the partnership agreement and in satisfaction and settlement of the Limited Partner's loan to the Partnership. Such transfers shall be completed prior to the effective date of cancellation as provided under paragraph 4 above.

7. A copy of this Certificate of Cancellation, properly certified by the Idaho Secretary of State, may be filed with the Ada County recorder or any other jurisdiction in cancellation

and termination of any Certificate of Assumed Business Name or other filings related to the organization and existence of the Partnership. Such filings shall be proof of the cancellation of the Certificate of Limited Partnership and/or any other such filings.

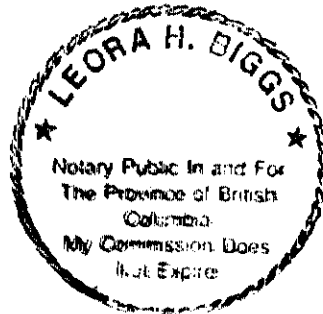


