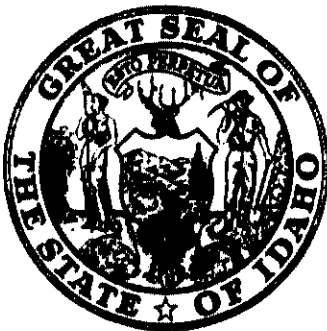

A. Paragraph 1 of the Articles of Incorporation of DEVELOPMENTAL ASSESSMENT INVENTORIES, INC. is deleted in its entirety and replaced by the following.

1. NAME. The name of the corporation is Developmental Advising Inventories, Inc.

B. Except for this designated amendment, the Articles of Incorporation filed on January 28, 1991 shall be unchanged.


