KNOW ALL PEOPLE BY THESE PRESENTS that these Articles of incorporation have been executed by the undersigned for the purpose of forming a business corporation in the State of Idaho under the Idaho Business Corporation Act.

ARTICLE I

The name of the corporation is RALSTON ENTERPRISES, INC.

ARTICLE II

The existence of this corporation shall be perpetual.

ARTICLE III

The purpose for which this corporation is organized is to include the transaction of any or all lawful business and the sale of any or all types of insurance (life, annuities, individual health and group health, disability, casualty, etc.) for which corporations may be incorporated under the laws of the State of Idaho.

ARTICLE IV
