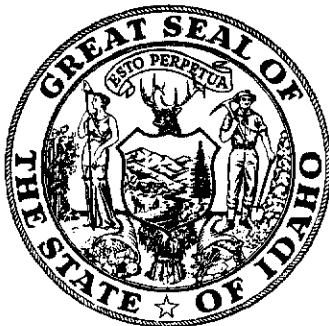

ARTICLES OF AMENDMENT

TO THE

ARTICLES OF INCORPORATION OF

MAGIC VALLEY REGIONAL MEDICAL CENTER AUXILIARY, INC.  
(A Non-Profit Corporation)

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Magic Valley Regional Medical Center Auxiliary, Inc.

SECOND: The following amendment to the Articles of Incorporation was adopted by the Board of Directors of the corporation on July 30, 1996, in the manner prescribed by the Idaho Business Corporation Act:

"ARTICLE XII

This corporation is organized exclusively for educational purposes within the meaning of Section (501)(c)(3) of the Internal Revenue Code."

THIRD: The number of membership certificates of the corporation outstanding at the time of such adoption was 183; and the number of membership certificates entitled to vote thereon was 183.

FOURTH: The number of membership certificates voted for such amendment was 183; and the number of membership certificates voted against such amendment was zero.

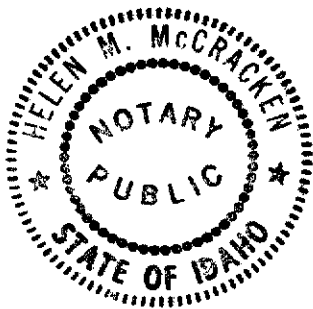
