## ARTICLES OF AMENDMENT OF

## IDAHO-OREGON FRUIT AND VEGETABLE ASSOCIATION, INC.

- A. The name of this corporation is IDAHO-OREGON FRUIT AND VEGETABLE ASSOCIATION, INC.
- B. The amendment hereinafter stated does not alter any provision of the original Articles of Incorporation dated the 5th day of September, 1962, but merely adds thereto an additional article which shall be designated as Article X the full text of which is as follows:

"ARTICLE X. No member of the Board of Directors of the corporation shall be held personally liable to any person or entity for any monetary damages or costs of suit as a result of a breach of a fiduciary duty as a Director provided that such limitation as to personal liability shall not eliminate or limit the liability of a Director for any of the following:

- A. For any breach of a Director's duty of loyalty to the corporation or its stockholders;
- B. For acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law;
- C. Provided for under <u>Idaho Code Section</u> 30-1-48;
- D. For any transaction from which a Director derived an improper personal benefit."
