THE BUSINESS of the Corporation shall be managed by its Board of Directors, each of whom shall be at least eighteen (18) years of age. The number of Directors of the Corporation shall be setforth in the Bylaws in a manner not prohibited by law. Until so changed, the number of Directors shall be (1). The Directors need be neither stockholders of the Corporation, nor residents of the State of Idaho.

THE PRIVATE PROPERTY of the shareholders shall not be subject to the payment of Corporate debts.

VII.
