(an Idaho professional limited liability company)

This Plan of Conversion of CRUMP ENTERPRISES, PLLC, an Idaho professional limited liability company, is intended to accomplish the conversion of CRUMP ENTERPRISES, PLLC, an Idaho professional limited liability company (the "PLLC"), as the "converting entity," into CRUMP ENTERPRISES, LLC, an Idaho limited liability company, as the "converted entity," in conformity with sections 30-22-401 et seq. of the Idaho Entity Transaction Act.

- 1. The Plan of Conversion shall be as follows and shall be consummated at such time as the following actions have been taken and approval for the same have been obtained:
 - a. Approval of the Plan of Conversion of CRUMP ENTERPRISES, PLLC, an Idaho professional limited liability company into CRUMP ENTERPRISES, LLC, an Idaho limited liability company, by the sole member of the PLLC.
 - b. Approval of the proposed Certificate of Organization of CRUMP ENTERPRISES, LLC, an Idaho limited liability company, which is attached hereto as *Exhibit A*, by consent of the sole member of the PLLC.
 - c. Execution of the Certificate of Organization of CRUMP ENTERPRISES, LLC, an Idaho limited liability company, by the sole member of the PLLC, and the filing of the same with the Idaho Secretary of State.
 - d. The converted entity has no existing private organic rules that are proposed to be included in a record of the converted entity;
 - e. The sole member of the PLLC shall execute and consummate the Plan of Conversion and file the Plan of Conversion in lieu of filing a Statement of Conversion and shall have the power to adopt all resolutions, execute all documents, and file all papers and take all necessary action deemed necessary or advisable for the conversion of CRUMP ENTERPRISES, PLLC into CRUMP ENTERPRISES, LLC.
- 2. CRUMP ENTERPRISES, PLLC an Idaho professional limited liability company is continuing its existence as CRUMP ENTERPRISES, LLC, an Idaho limited liability company.

- 3. Upon consummation of the Plan of Conversion, the sole member of the PLLC will automatically become the sole member of CRUMP ENTERPRISES, LLC, an Idaho limited liability company, with the same ownership interest and voting rights as he had as a member of the PLLC.
- 4. After the execution of the Plan of Conversion by the sole member of the PLLC, the sole member of the PLLC shall have the power to adopt all resolutions, execute all documents, file all papers and take all necessary action deemed necessary or advisable, if any, to transfer the assets and liabilities to CRUMP ENTERPRISES, LLC.
- 5. All liabilities of the converting entity continue as liabilities of the converted entity.
- 6. All property of the converting entity continues to be vested in the converted entity without transfer, conveyance or assignment.
- 7. An executed copy of the Plan of Conversion will be kept at the principal office of CRUMP ENTERPRISES, LLC, an Idaho limited liability company, located at 6363 W. Emerald Street, Suite 102, Boise, ID 83704.
- 8. This Plan of Conversion shall be and become effective upon filing.
