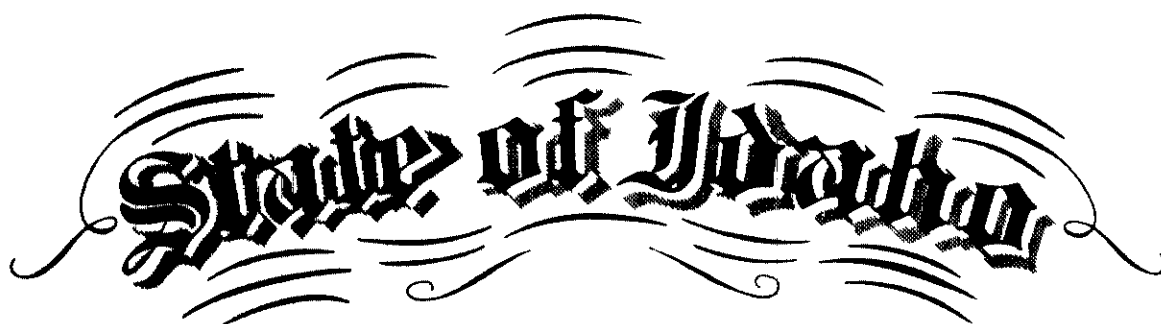

ARTICLES OF INCORPORATION
of
SLIDER INC.

A CLOSE CORPORATION

FIRST. The name of this Corporation is Slider Inc.

SECOND. Its registered office in the State of Idaho is to be located at 4696 Overland Road, Suite 440, Boise, County of Ada. The registered agent in charge thereof is Andrea Baisch, address "same as above". 83705 (15)

THIRD. The nature of the business and, the objects and purposes proposed to be transacted, promoted and carried on, are to engage in any lawful act or activity for which corporations may be organized under Title 30 of the Idaho Business Act. *The duration of this corporation shall be perpetual.* (15)

FOURTH. The amount of total authorized capital stock of the corporation is divided into 100,000 shares of no par value.

FIFTH. The name and mailing address of the incorporator is as follows: James W. Sparling, 1551 Cotterell way, Boise, Idaho 83709.

SIXTH: The powers of the incorporator are to terminate upon filing of the certificate of incorporation, and the name and mailing addresses of the persons who are to serve as managing stockholder(s) until their successors are elected are as follows:

SEVENTH. All of the corporations issued stock, exclusive of treasury shares, shall be held of record by not more than thirty (30) persons.


EIGHTH. All of the issued stock of all classes shall be subject to the following restriction on transfer permitted by Section 30-1-23A of the Idaho Business Corporation Act.

Each stockholder shall offer to the Corporation or to other stockholders of the corporation ninety (90) day "first refusal" option to purchase his stock should he elect to sell his stock.

NINTH. The corporation shall make no offering of any of its stock of any class which would constitute a "public offering" within the meaning of the United States Securities Act of 1933, as it may be amended from time to time.
